You are invited to submit an entry for our annual event to be held at Stithians Showground from Friday 14th August to Sunday 16th August 2026. **The closing date for entries is 30th June 2026.** We value your support for the events continued success.

Entry to the site is permitted from 10:00hrs on Sunday 10th August 2026. Please have your pass ready for scanning from this time. All normal road laws apply to the event.

Support vehicles will be allowed into the event area for the purpose of unloading, setting out and reloading exhibits only.

Camping will be within the Exhibitor Camping Field, a short walk from your marquee. **Do not pitch your caravan without being sited by your section secretary or the Camping Steward. You may be asked to move if you pitch without being sited.**

Vehicles arriving after 10.00am on Show days will not be permitted entry and will be directed to park in the Public Car Park until 5pm.

If accepted, you will receive your confirmation paperwork 2 – 4 weeks prior to the event.

Please include a photocopy of appropriate insurance certificate(s) with your entry form.

All electrical equipment used in the Craft & Model Marquee must possess a current and valid PAT certificate.

All food business operators must register with their local Environmental Department. Stalls selling sweets, cakes, savouries, drinks or any other foodstuffs are required to be registered. When attending the event please ensure that you have your Safer Food Better Business (SFBB) Registration with you. You will be unable to trade at the event without it.

We will provide a 240v, 6amp supply for a cost of £30.00 (inc VAT) for the duration of the event or part thereof. Please indicate on the form if required.
